**Sub:** Declaration of results of Surplus qualified Limited Departmental Competitive Examination for GDS for recruitment to the post of PA/SA for filling up of the unfilled vacancies of LGO exam 2015-16, 2016-17, 2017-18 & 2018 (01.04.2018 to 31.12.2018) held on 15.09.2019 - reg

In accordance with this office notification No Rectt/10-6/2019 dated 05.08.2019, the examination for recruitment to the cadre of Postal Assistant/Sorting Assistant from amongst Gramin Dak Sevaks (GDS) for the vacancy years 2015-16, 2016-17, 2017-18 and 2018 was held on 15.09.2019 (Sunday).

2. In accordance with the Directorate Instructions contained in letter No 17-08/2018-SPN-I dated 10.05.2019, as amended vide letters dated 10.06.2019, 20.06.2019, 28.06.2019, 11.07.2019, 23.07.2019 and 11.12.2019, the Data Entry Skill Test (DEST) for candidates qualified in Paper-I and Paper-II of the above exam held on 15.09.2019 was conducted on 09.02.2020.

3. In accordance with the Directorate instructions contained in letter No 17-08/2018-SPN-I dated 10.05.2019, the candidates who qualify in Paper-I, Paper-II and Paper-III separately shall be considered for final selection and their merit shall be drawn in order of marks secured in Paper-I since both Paper-II and Paper-III (DEST) are qualifying in nature.

4. The results of the candidates selected for the unfilled vacancies of LGO exam 2015-16, 2016-17, 2017-18 and 2018, for their parent division were already declared vide this office letter no of even dated 13.04.2020.

5. The list of the surplus qualified candidates (arranged in the order of merit) allotted to the unfilled vacancies available in the Divisions is shown in **Annexure - A**. In respect of candidates who scored equal marks in Paper-I, their inter-se seniority is fixed on the basis of length of GDS Service. Surplus qualified PWD candidates have been considered for the

unfilled horizontal reserved vacancies under relevant category. In case no eligible candidates was available for the identified PH category, as per instructions contained in DOPT OM No 36035/02/2017-Estt (Res) dated 15.01.2018, the vacancy was carried forward as 'backlog reserved vacancy' for the next recruiting year and filled up or exchanged with other candidates and the reservation was carried forward to next two recruiting years, as the case may be. The result will also be available on the Circle website ([www.keralapost.gov.in](http://www.keralapost.gov.in))

6. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of the information furnished by the Regions/Divisions and Units. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the surplus qualified candidates was not eligible to take up the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of surplus qualified candidates, as the case may be.

7. This result is further subject to outcome of Court /CAT cases, correction of clerical mistakes, if any. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions are requested to verify the current status of the candidature of the surplus qualified candidates before appointing the candidate. The candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be appointed and such cases should be referred back to this office.

8. Since this is a Direct recruitment and GDS are outside the Civil services and for the first time they will be joining as Government employees as 'Postal Assistant/Sorting Assistant', the Divisional heads are requested to carry out all required pre-appointment formalities as provided in prevalent rules and instructions issued from time to time on the subject along with the verification of genuineness of Community certificate/PWD certificate against which category they are being selected. Before appointment, it should be ensured that no disciplinary case is pending/contemplated or no penalty is current against the surplus qualified candidates. The Divisional Heads are also advised to re-check the pre-requisite conditions prescribed for candidates with reference to their recommendations made while forwarding the application forms.

9. Since the examination has been conducted using OMR sheets, the request for re-totaling/revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act.

10. The candidates of reserved category i.e SC/ST/OBC/EWS/PWD who are shown as qualified on their own merit are selected against UR vacancies.
