ORDER

Memo No.ST/3-3/Dlg/2017 dated at Trivandrum-33 the 24-11-2021

In compliance with the interim order dated 03/09/2021 in OA 625/2020 , the Competent Authority has ordered promotion of the under mentioned HSG I General Line official in Post Offices to the cadre of HSG I (Non Functional Grade) in the Pay Matrix Level-8 under Cadre Restructuring of Group 'C' employees in Post Offices and allotted as noted against the official.

2. If any vigilance/disciplinary case is pending against the above named official, she should not be relieved for posting without obtaining specific orders from this office. If any punishment is current in respect of the above named official, she should not be promoted before the expiry of the currency of punishment.

3. **Regional Head will issue necessary posting order to the official allotted to the Region.**

4. If the official have already been placed in the pay matrix level 8 and got her pay fixed is not eligible for fixation of pay on this promotion. Otherwise she will exercise her option under FR 22 (I)(a)(1) for fixation of pay within one month from the date of issue of posting orders.

5. If the official refuse HSG-I (NFG) promotion offered above, will not be eligible for regular/officiating promotions to HSG I(NFG) for one year from the date of refusal. She is also not eligible for placement in MACP till she accept regular promotion.

6. The promoted official should be relieved within thirty days from the date of issue of posting order.

7. In case, if the official fails to assume charge in the promoted post, within a period of 30 days from the date of issue of posting order, it will be presumed that she has declined the promotion offered.

8. In case the official is not willing to accept promotion, the representation declining the promotion offered should be received in this office within 30 days from the date of issue of posting order.

9. As per Directorate letter No: 25-04/2012-P.E.-I(Vol-III) dated 05-12-2018, LSG, HSG- II, HSG-I and HSG-I(NFG) Posts will be deemed to have been upgraded for a period of six months to the grade 14 only w.e.f the date it is filled up, i.e, from the date the promoted official assumes the charge. Otherwise, the post will remain in the lower grade. Also, as per Directorate letter No: X-20-24/2019-SPN-II dated 27-05-19, the effective date of promotion in all cases shall be from the date of actual promotion and seniority of the official shall be counted from the date of actual promotion on regular basis subject to stipulation of inter se seniority as per the mode of recruitment.

10. This promotion order issued will be subject to the final outcome of the OAs No: 76/2020, 44/2020 & 99/2020 filed before the Hon'ble CAT, Ernakulum.
