


**MINUTES OF ONE TIME REVIEW COMMITTEE FOR COMPASSIONATE
ENGAGEMENT(CCE) MEETING HELD AT O/o THE CPMG,
THIRUVANANTHAPURAM ON 20-04-2022 AND THROUGH VC ON 10.05.2022**

The One Time Review Committee on Compassionate Engagement (CCE) comprising the following members met on 20-04-2022 at Thiruvananthapuram and through VC on 10.05.2022 to consider the cases of dependents of deceased/missing Gramin Dak Sevaks which were rejected by the CCEs between the period 2005 to May 2017, for engagement as GDS on compassionate grounds in Kerala Postal Circle.

70 cases which were rejected between the period from 2005 to May 2017 were placed before the committee. Out of the 70 cases, 14 requests of compassionate engagement are set aside for next CCE by the committee for want of more documents. While examining each case, the committee kept in view the guidelines contained in Directorate Letter No 17-1/2017-GDS dated 30.05.2017, Directorate letter No.17-02/2018-GDS dated 08.03.2019, 17-01/2017-GDS(Vol-I) dated 09-02-2022, GDS (Conduct and Engagement) Rules 2021 amended from time to time and subsequent clarifications on the subject issued by the Postal Directorate.

The Committee examined 56 cases listed in the Annexure-I and recommended 29 cases and did not recommend 26 cases and one is kept pending due to SLP case pending. Secondary School Examination pass certificate of 10th standard with passing marks in Mathematics and English (having been studied as compulsory or elective subjects) conducted by any recognized Board of School Education of the Government of India/ State Governments/ Union Territories in India shall be a mandatory educational qualification for all approved categories of Gramin Dak Sevaks. The candidate should have studied the local language at least upto 10th standard [as compulsory or elective subjects] as declared by the state Government or as per constitutional provision relating to the 8th schedule of Constitution of India. The approved candidates should be engaged only after obtaining the required certificates duly verified, as per Directorate letter no. 17-39/2012-GDS dated 20.05.2016. Before issuing engagement order, the Divisional Head should ensure that the approved candidates fulfill the condition of basic computer training, which is a mandatory requirement for recruitment to GDS posts as prescribed vide Directorate letter No. 17-02/2018-GDS dated 08.03.2019. The candidates who do not possess requisite educational qualification at the time of death of the GDS or while applying for engagement on compassionate grounds were also considered as eligible and they may be given time upto maximum 3 years for acquiring minimum required educational qualification as prescribed with the terms and conditions mentioned in Directorate Letter No 17-01/2017-GDS(Vol-I) dated 09-02-2022. Upper age limit of the applicants can be relaxed wherever found to be necessary and the powers to relax the upper age limit of the applicant are vested with the Head of the Circle.


The post, against which the compassionate engagement recommended, is also indicated against each in Annexure-I. These GDS posts are identified by the concerned Divisional Heads.

The following requests for compassionate engagement are not recommended by the committee for the reasons mentioned below.

1) Smt Vimala B, W/o of Late K S Prabhakaran, GDS MD, Puthukulangara, Trivandrum South Dn

The case of Smt Vimala B is examined by the CCE convened. The CCE observed that the applicant is 62 yrs old and non matriculate. Hence the Committee for Compassionate Engagement is not recommending the case of Smt Vimala B.

2) Smt R Sudharmini, W/o Late V Unni, GDSMD, Kappil, Trivandrum North Dn

The case of Smt R Sudharmini is examined by the CCE convened. The division reported that the applicant had expired. Hence the Committee for Compassionate Engagement is not recommending the case of Smt R Sudharmini.

3) Ms. V R Deepthi, D/o Late G Viswananthan Pillai, GDS BPM, Patharam, Pathanamthitta Dn

The case of Ms. V R Deepthi is examined by the CCE convened. The following are the conclusions of the CCE. The widow of the deceased GDS is a state pensioner. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Ms. V R Deepthi.

4) Shri Ananthakrishnan A, S/o Late A Achuthan, GDSBPM, Chathakulam, Pathanamthitta Dn

The case of Shri Ananthakrishnan A is examined by the CCE convened. The following are the conclusions of the CCE. The widow of the deceased GDS is a state pensioner. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Shri Ananthakrishnan A.

5) Smt Jeena Ratheesh, D/o Late S Subramania Pillai, GDSMD, Mallassery, Pathanamthitta Dn

The case of Smt Jeena Ratheesh is examined by the CCE convened. The following are the findings of the CCE. As the ex-GDS was proceeded against under Rule-10 of GDS(Conduct & Employment) Rules 2001 for two charges, ie misappropriation of Government money & unauthorized absence and removed from service vide memo No. MOI/SO Mallassery dated 13-07-2006 and as per the guidelines laid down vide Directorate Letter No.17-01/2017-GDS(Vol-I) dated 12-11-2021, the Committee for Compassionate Engagement is not recommending the case of Smt Jeena Ratheesh.

6) Smt Fouziya Beevi, D/o Late Nadeera Beevi, GDS BPM Kadamancodu, Pathanamthitta Dn

The case of Smt Fouziya Beevi is considered by the CCE convened. The following are the findings of the CCE. The applicant was married at the time of death of ex-GDS. The applicant was not wholly dependent on the deceased GDS at the time of her death. The committee also observed that 2nd daughter of the deceased is already working as GDS BPM. In view of foregoing grounds, the Committee for Compassionate Engagement is not recommending the case of Smt Fouziya Beevi.

7) Smt Tintu Achenkunju, D/o Late V K Leelamma, GDS BPM Parampuzha, Kottayam Dn


The case of Smt Tintu Achenkunju is examined by the CCE convened. The following are the conclusions of the CCE. The applicant was married at the time of death of ex-GDS. The husband of the applicant is working as Higher Secondary Teacher. The applicant cannot be considered as wholly dependent on the deceased GDS at the time of her death and the family is not in an indigent condition. The husband of the deceased GDS is an ex-Serviceman and he is getting pension. There is an earning member in the family. In view of multiple reasons above, the Committee for Compassionate Engagement is not recommending the case of Smt Tintu Achenkunju.


8) Sri M R Ratheesh, Nephew of Late P K Santhakumari, Dak Sevak, Thazhathangady, Kottayam Dn


The case of Sri M R Ratheesh is examined by the CCE convened. The following are the findings of the CCE. The applicant is nephew of deceased GDS and nephew is not a dependent as per the extant rules. Hence the Committee for Compassionate Engagement is not recommending the case of Sri M R Ratheesh.

9) Sri Amal Raj, S/o of Late K K Rajappan, GDS MD, Karimpadam, Kottayam Dn

Sri Amal Raj has intimated that he has not interested for compassionate engagement. Hence the Committee for Compassionate Engagement is not recommending the case of Sri Amal Raj.

10) Smt Annalakshmi, W/o of Late Muthu, GDS MC, Kannickal, Idukki Dn

The case of Smt Annalakshmi is examined by the CCE convened. The following are the findings of the CCE. The applicant is a non matriculate (8th std failed). The son of the deceased GDS is employed in Indian Army. There is an earning member in the family. Hence the Committee for Compassionate Engagement is not recommending the case of Smt Annalakshmi.

11) Smt Asha G Thankappan, D/o of Late E N Jagadamma, GDS BPM, Kanichiyaar, Idukki Dn

The case of Smt Asha G Thankappan is examined by the CCE convened. The following are the findings of the CCE. The applicant was married and not wholly dependent on the deceased GDS at the time of her death. The husband of the applicant is a state govt employee, working in KSRTC. In view of the foregoing grounds, the Committee for Compassionate Engagement is not recommending the case of Smt Asha G Thankappan.


12) Smt K Amutha, D/o of Late V Karuppaswamy, GDS MD, Pius Nagar, Idukki Dn


The case of Smt K Amutha is examined by the CCE convened. The applicant has studied Tamil in 10th standard. The applicant has not studied Malayalam as a subject in 10th standard and does not have essential educational qualification. Hence the Committee for Compassionate Engagement is not recommending the case of Smt K Amutha.

13) Ms Arya Jose, D/o of Late Jose Mithchel, GDS BPM, Ezhumuttom, Idukki Dn

The case of Ms Arya Jose is examined by the CCE convened. The following are the conclusions of the CCE. The widow of the deceased GDS was working as a lab assistant in Newman College Thodupuzha (Aided College). Now she is a service pensioner and hence, the Committee for Compassionate Engagement is not recommending the case of Ms Arya Jose.

Daughter of the deceased is also employed as Postman. Since there are earning members in the family, the Committee for Compassionate Engagement is not recommending the case of Sri Mitlon M Issac.

15) Ms. Raji S, Sister of Late T Viswanathan, GDS MD, Vazhithala, Idukki Dn

The case of Ms. Raji S is examined by the CCE convened. The following are the findings of the CCE. The ex-GDS was married and hence the sister of married GDS cannot be considered as dependent. Therefore, the Committee for Compassionate Engagement is not recommending the case of Ms. Raji S.

16) Sri P T Dileep Kumar, S/o of P I Thankappan(invalidated), GDS MD, Veliyanad, Arakkunnam, Ernakulam Dn

It is reported by Ernakulam Division that Sri P T Dileep Kumar is now working as MTS, Mulanthuruthy. Hence the Committee for Compassionate Engagement is not recommending the case of Sri P T Dileep Kumar.


17) Smt Jisha M G, D/o Late G Gopalakrishnan, GDS MP, Aluva Dn


The case of Smt Jisha M G is examined by the CCE convened. The following are the findings of the CCE. The applicant was married and not wholly dependent on the deceased GDS at the time of her death. The widow of the deceased is working as a Anganwadi worker. The husband of the applicant is working in a Pvt firm and brother of the applicant is also working in a Pvt firm. Hence the Committee for Compassionate Engagement is not recommending the case of Smt Jisha M G.

18) Smt K G Sujatha, W/o of Late P K Sivasankaran Nair, GDS BPM, Kadayiruppu, Aluva Dn

The case of Smt K G Sujatha is examined by the CCE convened. The son of the deceased GDS is working in Air Force. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Smt K G Sujatha.

20) Smt. Praveena P B, D/o late Balakrishnan P T, BPM, Katungode, Thrissur Dn

The case of Smt Praveena P B is examined by the CCE convened. The following are the findings of the CCE. The applicant was married and not wholly dependent on the deceased GDS at the time of his death. Hence, the Committee for Compassionate Engagement is not recommending the case of Smt Praveena P B.

21) Smt P K Vijayalakshmi, W/o of Late M K Rajan, GDS MD, Adat, Thrissur Dn



26) Sri V P Sasikumar, S/o Late R P Raman, GDSMD, Cherusola, Tirur Dn



The following 14 requests for compassionate engagement are set aside for next CCE by the committee for want of more documents.


