Sub: - Declaration of result of the Limited Competitive Examination from GDS held on 24.10.2021 (DEST held on 24.04.2022) for recruitment to the cadre of Postal Assistants / Sorting Assistants in Divisions/ Units for unfilled vacancies of LDCE meant for Postman/Mail Guard/ MTS for the vacancy year 2021 - reg.

In pursuance to Directorate letter No. A-34012/05/2021-DE dated 10.09.2021, Limited Competitive Examination from Gramin Dak Sevaks (GDS) for recruitment to the cadre of Postal Assistants / Sorting Assistants in Divisions/Units for unfilled vacancies of LDCE meant for Postman/Mail Guard/ Despatch Rider/ MTS for the vacancy year 2021 (01.01.2021 to 31.12.2021) was conducted on 24.10.2021. Data Entry Skill Test (DEST/Paper-III) for the candidates who qualified in Paper-I and Paper-II of the examination was conducted on 24.04.2022.

2. Now the Competent Authority is pleased to announce the result of the Competitive Examination held on 24.10.2021 and DEST held on 24.04.2022. The names of the candidate, declared successful for recruitment to the cadre of Postal Assistant in his present Division is detailed below.

3. In accordance with the instructions contained in Directorate letter No. 17-08/2018-SPN-I dated 10.05.2019 and subsequent letters, the candidates who qualified in Paper-I, Paper-II and Paper-III separately have been considered for final selection and their merit is drawn in order of marks secured in Paper-I since both Paper-II and Paper-III are only qualifying in nature.

4. In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his/ her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/ appointment letters issued.

5. The Heads of the Divisions concerned are requested to immediately finalize the candidature of provisional candidates within 15 days. It may also be ensured that no provisional candidate, if found in the list of selected candidates, is given promotion/ appointment under any circumstances without regularization of his/her candidature and such cases should be referred back to this office.


6. Since this is a Direct recruitment for GDS officials and GDS are outside the Civil services and for the first time they will be joining as Government employees as 'Postal Assistant', the Divisional heads are requested to carry out all required pre-appointment formalities as provided in prevalent rules and instructions issued from time to time on the subject along with the verification of genuineness of Community certificate against which category they are being selected. Before appointment, it should be ensured that no disciplinary case is pending/ contemplated or no penalty is current against the candidates. The Divisional Heads are also advised to re-check the pre-requisite conditions prescribed for candidates with reference to Recruitment Rules and their recommendations made while forwarding the application forms.

7. This result is further subject to outcome of various cases pending before the Hon'ble Court/ CAT.

8. Since the examination has been conducted using OMR sheets, the request for re-totalling/ revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act.


9. The Divisional Heads may ensure that appointment orders are issued to the candidates within 15 days by reporting compliance.
