Sub: - Declaration of result of Limited Departmental Competitive Examination (LDCE) from Postman/ Mail Guard, Despatch Rider and MTS for recruitment to the cadre of Postal Assistant/ Sorting Assistants in Postal Division/ Units (including Postal Stores Depot), RMS and MMS for Departmental Quota of vacancy for year 2021 (01.01.2021 to 31.12.2021), held on 24.10.2021 and DEST held on 24.04.2022 – reg.

Ref: - This office letter of even number dated 13.09.2021

In pursuance to Directorate letter No. A-34012/05/2021-DE dated 10.09.2021, Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postal Assistant/ Sorting Assistant from Postman/ Mail Guard and MTS for the vacancies of 2021 was conducted on 24.10.2021. Data Entry Skill Test (DEST/Paper-III) for the candidates who qualified in Paper-I and Paper-II of the examination was conducted on 24.04.2022.

2. Now the Competent Authority is pleased to announce the result of the LDCE held on 24.10.2021 and DEST held on 24.04.2022. The names and designation of candidates, declared successful for promotion to the cadre of Postal Assistant/ Sorting Assistant in each Division/ Unit is enclosed as Annexure-I.

3. The candidates of reserved category i.e. SC/ST, who are selected on their own merit have been considered against the 'UR' vacancy. Candidates in the list published vide this office letter No. Rectt/10-3/2021(CON) dated 12.04.2022, who qualified in Paper-III have been considered for final selection and their merit is drawn in order of marks secured in Paper-I. Since Paper-II and Paper-III are only qualifying, marks secured in Paper-II and Paper-III was not added to the marks secured in Paper-I to decide the merit.

4. As per the instructions contained in Directorate letter No. 04-08/2019-SPN-I dated 11.12.2020, if Candidates having equal marks in Paper-I belonging to different feeder cadres, the official in the higher grade will be higher in rank than the official in the lower grade. In case of officials having equal marks belonging to the same feeder cadre where there is common seniority/gradation list, official senior in such list will be higher in rank.

5. In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his/ her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/ appointment letters issued.


6. The Heads of the Divisions concerned are requested to immediately finalize the candidature of provisional candidates within 15 days. It may also be ensured that no provisional candidate, if found in the list of selected candidates, is given promotion/ appointment under any circumstances without regularization of his/her candidature and the same may be brought to the notice of Circle Office for necessary action.

7. This result is further subject to outcome of various cases pending before the Hon'ble Court/ CAT.

8. If any vigilance/disciplinary case is pending against any of the candidates, they should not be relieved for posting without obtaining specific orders from this office. If any punishment is in currency, in respect of any of the candidates, he/she should not be promoted before the expiry of the currency of punishment.

9. The Divisional Heads may ensure that appointment orders are issued to the candidates within 15 days by reporting compliance.
