- 2. In case any vigilance/disc. case, of the type referred to in O.M. No. 22011/2/86-Eatt (A) dated 12.01.88 from DOP&T circulated vide Directorate Memo No. 25-19/88-SPG dated 01.05.88 (subsequently) revised vide DOP&T memo No. 22022/4/91 Estt. (A) dated 14.09.92 circulated vide Directorate Memo No. 25-19/88-SPG dated 13.10.92 is pending against the officials, the official should not be relieved for posting without obtaining specific orders from the appropriate authority.
- 3. The allotment process may please be completed by concerned Regions within 10 days of receipt of this order. Divisional Heads will issue necessary posting orders in respect of officials allotted to the respective Division within 10 days of receipt of the allotment orders.

- 4. Those who have already been placed in the pay matrix level 5 under the MACP scheme and got their pay fixed are not eligible for fixation of pay on this promotion. Others if any, will exercise their option under FR 22(I)(a)(1) for fixation of pay within one month from the date of issue of posting orders.
- 5. Those who decline LSG Accounts Line promotion now offered will not be eligible for regular/officiating promotion to LSG for one year from the date of refusal. Such officials are also not eligible for placement in MACP till they accept regular promotion.
- 6. Wherever movement of officials is contemplated as per this order, they should be relieved within thirty days from the date of issue of posting order.
- 7. In case, if the officials fail to assume charge in the promoted post, within a period of 30 days from the date of issue of posting order, it will be presumed that he/she has declined the promotion offered.
- 8. In case the officials are not willing to accept promotion, the representation declining the promotion offered should be received in this office within 30 days from the date of issue of posting order.
