

**MINUTES OF THE CIRCLE RELAXATION COMMITTEE MEETING HELD AT  
THE OFFICE OF CHIEF POSTMASTER GENERAL,  
THIRUVANANTHAPURAM ON 24-11-2022**

The Circle Relaxation Committee comprising of the following Officers met at the office of the Chief Postmaster General, Thiruvananthapuram on 24.11.2022 for considering the applications for appointment on compassionate grounds in relaxation of normal Recruitment Rules.



2. A system of allocation of Relative Merit Points (RMPs) to various attributes based on a hundred point scale is communicated vide Directorate letter no.17-1/2022-SPG-II dated 23.03.2022. The Committee analysed each case received based on these parameters.


3. As per the scheme for compassionate appointment circulated in DoP&T OM No.14014/6/14-Estt(D) dated 09.10.1998 and No 14014/02/2012-Estt(D) dated 16.01.2013, the Committee constituted for considering requests for appointment on compassionate grounds should limit its recommendation to appointment on compassionate grounds only in really deserving cases and only if vacancy meant for compassionate appointment is available, within a ceiling of 5 % of vacancies falling under DR quota.

4. The last CRC meeting was held on 20.10.2021 and 21.10.2021.

6. a) Vacancies reserved under compassionate appointment quota against direct recruitment quota vacancies of PA/SA, Postman and MTS for the year 2021 are as follows.

b) The vacancy under compassionate appointment quota for DAP, Trivandrum for the recruitment year 2016-2017 is MTS - 1 (one).

7. Total of 10 applications for consideration under compassionate appointment received since the last CRC and the under mentioned 3 applications considered in the last CRC which were not recommended are considered in the present CRC. One application for filling up the MTS post of DAP too was considered by the CRC.

8. The following three compassionate cases considered and not recommended in the last CRC meeting held on 20.10.2021 and 21.10.2021 have been re-considered in this CRC meeting as per Directorate instructions vide letter no.17-1/2022-SPG-II dated 23.03.2022 which prescribes to consider each case three times continuously in a row and if a case is not recommended in third consideration depending upon RMPs of the case, the CRC which is considering the case in third time, shall reject the case.
